SYNOPSIS OF MEETINGS

October 4, 1986

A letter was read from Bruce Clark, County Clerk. According to his letter, the society will not be given access to the indexes for courthouse records. We will continue requesting access.

The program was a tape on "Finding Records of French Canadians". The tape dealt mainly with New York State and recommended buying a good English/French dictionary. There were essentially two types of French Canadians who immigrated to New York: 1) Itinerant or temporary and 2) Permanent settlers. French Canadians were very restless and migrated a great deal. The most important record is the census, especially after 1850. Quite often French Canadians did go back to their home town and many times it was an extended visit.

Two periods of early settlement were 1) 1609-1830, and 2) 1830 on. The two French Canadian regiments formed during the Revolutionary War were called "Congress' Own". In 1783 a resolution was passed rewarding the French Canadians who fought in the Revolutionary War. New York State awarded them a tract of land in Clinton County. It took another three years for New York State to straighten everything out and, in 1786, the French Canadians received their land in Clinton County. During the interim three years, they lived mostly in Albany or Fishkill, New York. The settlement became know as the Canadian Settlement (or Refugee's Tract). Shazetown and Champlain were the main settling towns.

One good source for locating these French Canadians is the "Index to Revolutionary War Pension Applications". In order to qualify for this land, the two regional commanders had to provide a list of the soldiers in their regiments. This was in the form of a Muster Roll. These can be found in the New York State Library (Land Papers Vol. 47). Also in the New York State Library are the Balloting Book and other records relating to military bounty lands. To earn land, you had to prove you were a French Canadian refugee who had suffered at the hands of the British. At the 1790 census, this was listed as the only French Canadian settlement in New York.

In 1837 during the Patriot War, many French Canadians actively resisted the British and fled across the border into the U.S. Also, Canada was suffering from a depression at this time. This was the first large immigration of French Canadians into the U.S. After the Civil War, U.S. Industries were actively recruiting French Canadians to work in their factories. This was due to the fact that French Canadians were hard workers who didn't strike. Vital records aren't nearly as good a source as church records for Information. Catholic baptism records usually include the maiden name of the mother, date and place of birth, date of baptism, name of godparents (usually a member of the family), and name of the Priest. This record will be more accurate than civil birth records due to the language factor.

When trying to locate records, many Priests were on a circuit and the records would be at his home parish instead of where the baptism took place. State and Federal census records are absolutely vital in tracking down French Canadian ancestors.

November 1, 1986

It was decided that a workshop would be held either in April or September of next year. If we have an evening workshop, it would only be necessary to guarantee 35 people.

The Nominating Committee announced the slate of officers for next year. A vote will be taken at the December meeting.

December 1, 1986

The "1894 Portrait & Biographic Record" books have arrived and are available for purchase at the Kankakee Public Library. It was decided that we will have a September Workshop instead of a May Workshop this year.

The slate of officers presented at the November meeting were voted into office (see Page 2).

The program speaker was Mr. James Gill, who spoke on "Taking Your Genealogy on the Road".

Before taking your genealogy on the road, Mr. Gill stressed four steps: Planning, Organization, Preparation and Execution.

Planning: If you are going to take along family members, be sure to make arrangements for things they can do while you are doing research.

Organization: You must always keep track of records that don't have your information in it as well as ones that do. It would be good to keep a book of all sources you have researched and Mr. Gill recommended "Cite your Sources" by Richard Lackey as an excellent reference guide. Once you start a book, it should be divided by sources searched such as census, vital records, printed records, etc.

Your research thinking should focus on what you want to find out. From there you should decide what kind of records will give you that information. Make a list and put those sources in an order of probable success. Decide what your research targets are.

Before you take your genealogy on the road, know what's there before you go. If you plan to go to a library, write and ask for a list of their holdings. Never go for something that you can obtain locally. Always use the closest source.

One up and coming tool is O.C.L.C., on-line computer library center. This is a computer data base that contains catalogs of many libraries. You will need to know either the author's name or title to get the needed information. College libraries often have O.C.L.C. Now you are organized!

Preparation: Write to the record center and tell them when you plan to visit. Tell them what records you are interested in seeing. They may be stored in a warehouse and not be available for your use. Ask their hours and day schedule. Ask them if records you are interested in will be available for research. Ask if they require any fees or membership to use. Ask about photocopiers and cost so that you can be prepared with proper change. Ask if they have any specialized indexes and always send a S.A.S.E.

Take with you:

1. Log of sources searched.
2. Research plan.
3. Plenty of loose leaf notebook paper.
4. Plenty of pens and pencils.
5. Jiffy stapler and aspirin may be helpful!

Now you can do the research:

1. Dress for success.
2. Get there five minutes early.
3. Introduce yourself to the head person and tell them that you wrote and thank them for their response (butter them up).
4. Ask the clerk how his records are organized.
5. Spend the maximum time copying instead of reading and make a bibliography reference of everything you look at.
6. Be sure to check the Table of Contents as well as the Index.

The real fun is when you get home and have all this information to analyze!!

MOMENCE ITEMS

Taken from The Kankakee Gazette, August 24, 1871

Building is brisk in Momence. The new dwelling house of E. Richardson, Jacob Ruger, Geo. S. Blakeslee and Dr. Shrontz are finished, or nearly so; that of E. R. Kendall is well under way. John Deersen has just commenced his new dwelling house, and John Shrontz is at work rebuilding his hotel on the site of the one lately burned.

The stone block on Front street is being rapidly built. This block will contain five stores and a bank. The two west stores belong to Wm. G. Nichols, and each store is to be 22 feet wide by 80 feet deep. The next store belongs to J. B. Worcester, 22 feet wide by 80 feet deep. The bank belongs to J. B. Durham, to be 19.5 feet by 40 feet. The east two stores belong to J. B. Wicks, and each store to be 22.5 feet wide by 80 feet deep. The entire block will be two stories high. G. A. Marcy and Fred Clark are doing the mason work, and L. B. Clark and E. E. Lincoln the carpenter and joiner work for Nichols, and David N. Brown, Chicago, has contracted to build the balance of the block.

The walls of the new school building are completed or nearly so, and they are now raising the mansard roof. Mr. Hibbard, the builder, is entitled to great credit for the quiet but efficient way he has so far built the building. Mr. Hibbard is a gentleman and we can cheerfully recommend him to any one who war an honest job done by an honest man.

James Moran reports a volunteer watermelon vine in his patch of Osage orange that measures 22 feet from the end of its nose to the tip of its tail. (Some vine we think).

Slocum Wilber reports over 100 acres in vines alone and about 100 acres more in other garden truck, outside of Beaver Lake settlement. Mr. Wilber furnishes seeds enough to the Beaver Lake people to plant the whole settlement, including the seat of war, and takes the seeds in the west, drying and preparing them for market himself, paying a stated price for pound for the dry seeds. Last year he paid over \$1500 to the seed raisers at Beaver Lake. Mr. Wilber, this week, got an order from Connecticut for 22,000 lbs. turnip seed, which strained his pile a little. If anybody can make a better show of his seeds than Mr. Wilber let him speak now or forever after hold his peace.

Our little town has been very lively this Spring. Many land transfers have been made, and who would believe it, farmers become middle men, middle men farmers! L. B. Merrick, an old farmer has exchanged places with John Blain of the firm of Blain Brothers. So John is behind the plow, and our farmer has taken the hay seed out of his head and waits on his customers.

Another new store is to start next week. Julian and Fred Blain have induced Archer Bell (another farmer) to be one of the members of the firm of Blain Bros. & Co.

If you want to sell any fine looking horses just come here. You will find Brosseau & Moisant buying them by the wholesale. They have engaged the services of a man in New York to whom they ship nearly every week.

J. F. Campbell and Sam Williams, two enterprising farmers, have gone with a car load of horses to New York. There seems to be "greenbacks at the bottom". So says Frank.

E. Wright, our well known dairyman, is making things lively. He has one of the largest dairies in the vicinity of Chicago. Every morning at 6:30 sharp his express wagons (four in number) come loaded with about 30 cans, containing 8 gallons each of milk, to the depot to meet the train which carries it into Chicago.

On the 7th of April next we are to vote whether we shall have a high school or not in our township. This is a good move. Manteno needs something higher than our common district schools. It will be a benefit to the younger class and enable them to finish their literary education at home, without going abroad where very often they lose their ancient love for our rustic town.

A special telegram from Chicago, dated March 26, brought us the news that Charles Skinner was "booked" for life. We suspect something when he left us a few days previous in a rather sly manner. That's all right, Charley; we will excuse you provided you will come back after your bridal tour to New York.

INDIANA ANCESTORS

Taken from The Indianapolis Star, August 31, 1986

German archivists have learned that emigrant sailing lists were kept for the port of Bremen, Germany, beginning in 1832. The lists were used to compile statistical reports for the government and port authorities. Because of a lack of storage space, the valuable lists from 1832 to 1872 were destroyed in 1874. Thereafter, the lists were shredded every two years.

It was not until 1907 that original lists were kept again on a permanent basis. Then, on October 6, 1944, all remaining lists were destroyed when Allied bombing attacks destroyed the Statistical Land Office. This was a serious loss because Bremen was the most active of the German seaports and handled three times as many emigrants as Hamburg.

Transcripts of some 20th century lists - 1906, 1908, 1913 and 1914 - recently were discovered at the German State Archives in Koblenz, but no 19th-century transcripts have yet been discovered. In 1985, Gary J. Zimmerman and Marion Wolfert compiled German Immigrants: Lists of Passengers Bound from Bremen to New York, 1847-1854. The work is a partial reconstruction of the Bremen records based on American sources rather than German. It is a record of arrival rather than departures. Place of origin is provided for 35,000 emigrants along with name, age, date of arrival, name of ship and citations of the original source material.

Zimmerman and Wolfert just have completed compilation of the second volume, German Immigrants: Lists of Passengers Bound from Bremen to New York, 1855-1862. This volume is a continuation of the previously noted volume. Again, this is a partial reconstruction of Bremen passenger lists based on American sources, specifically, Passenger Lists of Vessels Arriving at New York. Included in this volume are all Bremen passengers of the 1855-62 period for whom a specific place of origin is noted in the original manifests.

Of the total number of passenger arrival records, roughly 21 percent provide such information, giving access to about 35,000 immigrant records. The remainder give only Germany as the place of origin.

In the original lists, many given names and surnames were partially or completely anglicized. In those instances, an entry has been added under what is assumed to be the original German spelling. Misspelled place names were corrected on a limited basis. Immigrants names are arranged in alphabetical order, and family members are grouped together usually under the head of the household. Age, place of origin, arrival date and ship's name plus specific citations to the original source materials are given.
